FRM have a thorough understanding of the pressures faced by Local Authorities, particularly in response to policy changes posed by the National Resources & Waste Strategy, budget cuts and achieving net zero aspirations. Our recent project work has involved assessing the cost and performance implications, whilst considering future operational challenges and opportunities.

We are experienced modellers of alternative collection systems, deriving costs, operational parameters and performance. These consider the consistency models proposed in national policy, organic waste collection configurations and differing residual waste treatment collections. We regularly support findings with detailed benchmarking and operational observations. We can also incorporate DRS / EPR impacts arising from the National Resources & Waste Strategy. We apply the KAT (Kerbside Analysis Tool) model developed by the Waste & Resources Action Programme (WRAP) for collection systems. We have modelled over 60 authorities in England using this tool.

FRM support Local Authorities seeking to understand the carbon impacts of their waste management service. We have delivered numerous carbon assessments, using the WRATE model (or other tools), to support procurement exercises, SEA, Options Appraisals or other LCA related applications. Each seeking to inform decision making in line with local and national net zero aspirations. FRM also have the ability to provide communication support to aid in the implementation of new or changing services including the delivery of campaigns at a variety of levels and content provision.

We have also evaluated trade waste collections and provided business cases for developing services. We support Councils in developing commercial opportunities for infrastructure and services. FRM have also worked with a wide range of waste management partnerships and combined authorities to quantify potential efficiency savings from joint working and through consideration of net costs between WCAs and WDAs. This includes: sharing of infrastructure; reform of recycling credits; sharing of services; reform of services; commercialisation, and; alternate governance arrangements.

These include: externalising services; in-house services, and; Teckal exempt companies.
